Dear Joe,

As usual, we live in challenging times. You and I lived through many challenging county budgets over the years and the 2023 budget is no exception. But I see that you are investing in staff salaries because as you and I know, these hard-working people are key to achieving our goals for the citizens of Dane County.

In my retirement I have enjoyed serving on the Dane County Historical Society board of directors. We have a good group of distinguished members but the glue that keeps us going is our amazing staff person, Rick Bernstein, a former field officer for the State Historical Society.

As you know, we maintain a large repository of Dane County history in the form of maps, photographs, books and other textural materials. In exchange for our members raising \$50,000 for the Lussier building, we were given a long-term lease in the lower level of the facility. We were also charged with providing historical markers throughout Dane County.

In 1977, our funding was \$6,000 (or \$28,000 in today's dollars). In 1984 it was \$10,000. Today it is less than \$5,000 and we are hanging on by a thread. Thanks to Rick, we have managed to accomplish special projects through grants and appeals to our membership. But we desperately need a baseline of funding in order to keep our part time staff person. He is the one who prepares our newsletter that explains our digitizing projects and raises the necessary funds. Rick organizes our meetings and sets the agenda. Rick laid the groundwork for the Interpretation Plan for Capital Springs – the result of our partnership with Dane County Parks, Friends of Capital Springs, Ho-Chunk Nation and the Madison Metropolitan Sewer District.

When researchers, genealogist and others need access to the Dane County Archives^{*}, we need staff to provide it. We are asking for an additional \$5,000 to continue to preserve and promote Dane County history. If you could possibly have time in your busy schedule, I would love to meet with you to talk more about our request.

Once our history is lost, it is gone forever.
